Pursuant to the Directive on Procurement in the Diplomatic and Consular Missions of the Republic of Serbia No.716/GS of 20 May 2013 and the Instruction on the Manner of Procurement Execution in the Diplomatic and Consular Missions of the Republic of Serbia No.716-2/GS of 3 July 2013; the Commission makes a decision on procedure suspension:

**DECISION
ON PROCEDURE SUSPENSION**

The procedure for procurement execution of works on adaptation of the premises at the address 7 Dering Street, London W1S 1AE, United Kingdom, No.131-2/2020 of 29/01/2020.

Explanation

The procurement procedure was suspended at the stage after the deadline for submission of bids, and following the procedure for opening the bids for execution of works on adaptation of the premises at the address 7 Dering Street, London W1S 1AE, United Kingdom.

The reason for suspending the procedure is that all submitted bids are unacceptable because they exceed the estimated value and available funds of the Contracting Authority, and therefore the conditions for awarding the Contract have not been met.

On the day of 29 January 2020, the Contracting Authority made a decision to initiate the procedure for the procurement No. 131-2/2020.

Invitation for bidders to submit a bid and Tender Documents were published on the website of the Contracting Authority, on 06 March 2020.

The deadline for submission of bids expired on 27 March 2020 at 12 pm. Until then, 6 bids have been received to the address of the Contracting Authority, as follows:

The total estimated value of the procurement is **30.000.000,00** dinars, VAT excluded i.e. **196.987,76 GBP**, VAT excluded.

Bearing in mind that all the submitted bids exceed the estimated value of the procurement, i.e. the available financial resources of the Contracting Authority, the Commission proposed to the Contracting Authority to suspend the procedure.

On the basis of the above, the decision was made as in the disposition.
