Subject of procurement:

The subject of procurement is the execution of construction works on the rehabilitation of the roof, refurbishment of the facade and the decoration of rooms of the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom.

The subject of procurement is determined more specifically by the Tender documents.

Description of the subject of procurement:

Based on the Decision on initiating the procedure for awarding the contract number: 1270/2018, dated 29/11/2018, for the procurement of construction works on the rehabilitation of the roof, refurbishment of the facade and the decoration of rooms of the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom. The Embassy of the Republic of Serbia in London invites you to submit your bid in writing which must be prepared in full according to the Tender documents.

Scope of works orientation:

Performing construction works on the rehabilitation of the roof, refurbishment of the facade and the decoration of rooms of the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom.

The Tender documents necessary for the submission of a written bid can be collected every working day, from 10 am to 2 pm, at the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom, starting from the date of announcing the Invitation to submit a bid, or it can be downloaded from the website of the Embassy of the Republic of Serbia in London www.london.mfa.gov.rs

Deadline, place, time and manner of submitting a bid:

It is considered that bids are submitted on time, if they are submitted to the contracting authority by 08/12/2018 December 2018 until 11 am.

All bids are to be submitted in sealed envelopes personally or posted to the address of the contracting authority:

The subject of the procurement should be written on the envelope - **Procurement Bid** - Performing construction works on the rehabilitation of the roof, refurbishment of the facade and the decoration of rooms of the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom.

The envelope or a box with the bid must be labeled: "**BID - DO NOT OPEN**" on the front, with the full name of the bidder, address, telephone and the contact person on the back.

Bids submitted to the contracting authority after the deadline will not be taken into consideration, regardless of the manner of delivery. Upon the completion of the bid opening process, the Bid Procurement Committee will return any untimely submitted bids to the bidders unopened, with the indication that they have not been submitted on time.

Criterion and its elements for selecting the best bid:

The decision on awarding a contract for the procurement of goods will be made using the criterion of the lowest offered price, according to previously fulfilled all requirements and obligatory conditions of the contracting authority specified in the Tender documents.

Bids opening shall take place after the bids submission deadline, i.e. on 10/12/2018 2018, beginning at 10 am, at the Embassy of the Republic of Serbia, 28 Belgrave Square, London, SW1X 8QB, United Kingdom.

The Committee of the contracting authority shall make a report on the professional evaluation of the bids, within five days from the day of bids opening and the completion of the possible negotiation procedure.

The Committee shall, within five days from the day of bids opening, make a proposal for awarding the contract.

Deadline for concluding a contract:

The contract with the selected bidder will be concluded within 10 days from the date of the decision to award the contract.
